CHAPTER 93: PARKS AND RECREATION

Section 93.01 Rules and regulations of Williams Island

§ 93.01 RULES AND REGULATIONS OF WILLIAMS ISLAND.

- 1. The intent of this recreation area is to provide a clean, healthy and safe park. The following rules are hereby enacted.
- 2. Alcohol or other illegal substances will not be allowed.
- 3. Gambling will not be allowed.
- 4. Pets are to be on a leash and under the control of the owner.
- 5. Pets will not be allowed in the water.
- 6. Loud or abusive language or fighting will not be tolerated.
- 7. Radios, tapes, VCRs and other audio equipment must be kept at a low-volume level so as not to disturb others, whether on or off Williams Island.
- 8. Litter and trash are to be placed in the containers provided.
- 9. Parking of vehicles is limited to the designated areas only, not on the grass.
- 10. Park tables are not to be placed in the water or at the water's edge.
- 11. Swimming will be allowed at one's own risk. No lifeguards are provided.
- 12. An assembled group of 12 or more will be required to obtain a permit from the township office. This permit must be approved and obtained at least one week in advance accompanied with fee \$100, non-refundable..
- 13. The hours for this recreation area will be from 9:00 a.m. to 11:00 p.m.
- 14. The use of this area, outside of these hours, will require a special permit from the township office.
- 15. Persons seeking such a permit must be at least 21 years of age and must present proof of name, age, phone number and address.
- 16. The rules stated in this section will be enforced by the Sheriff's Department and the state police.

WILLIAMS ISLAND PERMIT REQUIREMENTS

REQUIREMENTS:

Each application shall be accompanied by a detailed explanation, including drawings and diagrams of the overall site, of the prospective applicant's plans to provide for the following:

- Police and Fire Protection
- Food and water supply.
- Health and sanitation facilities.
- Medical services and facilities including emergency vehicles and equipment.
- Vehicle access and parking facilities. No Over Night Camping Allowed.
- Illumination facilities.
- · Communications facilities.
- Facilities for clean up and waste disposal.
- Insurance and bonding arrangements.
- Island clean-up during and after the event, must be procured.

REVOCATION:

The Township Board may revoke a license whenever the permit holder, their employee/s or agent fails, neglects or refuses to fully comply with any and all provisions, regulations, ordinances, statutes, or other laws incorporated herein, by reference with the Township Ordinance No. 3, passed 7/18/1973.
