zoning ordinance regarding marijuana facilities in the 154.065 A – Agricultural Districts; 154.070 to the zoning ordinance regarding Marijuana facilities in the C-H Highway Commercial zoning district and a new subsection 154.037 to the Zoning Ordinance authorizing and special land uses.
