## **POVERTY EXEMPTION GUIDELINES FOR 2023** (UNDER mcl 211.7U - New Requirements)

## **NEW PROVERTY EXEMPTION REQUIREMENTS EFFECTIVE 2023**

A claimant may Request a Poverty Exemption and Appeal the Property's Assessment to the Board of Review in the current year.

## FEDERAL POVERTY INCOME STANDARDS:

Size of Family Unit

The following are the prior tax year (2020) federal poverty income standards that the United States Office of management and Budget recommend that federal departs and agencies use. Yates Township has adopted these Income Levels for the basis for the granting "Poverty Exemptions". These are adjusted annually.

To be eligible for a poverty exemption in the Township of Yates FOR 2023 your gross income may NOT exceed these guidelines. If your gross income exceeds the levels listed below you do not qualify for a **Poverty Exemption:**

| 7 persons                      | \$ 45,420                 |
| 8 persons                      | \$ 50 560                 |
| For Each Additional Person add | \$ 5,140                  |

**Note:** PA 390 of 1994 states that the poverty exemption guidelines established by the governing body of the local assessing unit <u>shall</u> also include an asset level test, An asset test means the amount of cash, fixed assets or other property that could be used, or converted to cash for the use on the payment of property taxes, The asset should calculate a maximum amount permitted and all other assets above the amount should be considered as available, The asset levels listed below:

| 1 person           | \$ 24,000 |

| 2 persons          | \$ 30,000 |
| 3 persons          | \$ 35,000 |
| 4 persons          | \$ 41,000 |
| 5 persons          | \$ 46,000 |
| 6 persons          | \$ 52,000 |
| 7 persons          | \$ 58,000 |
| 8 persons          | \$ 64,000 |
| 9 persons of more. | \$ 70,000 |

**Note:** P.A. 135 of 2021 changes the requirements for filing documentation in support of a poverty exemption to allow an affidavit (Treasury Form 4988) to be filed for all persons residing in the residence who were not required to file federal or state income tax returns in the current year or in the immediately preceding year, This does include the owner of the property who is filing for the exemption.

**Note:** P.A. 253 of 2020 removes the word "supervisor" from statue. Only BOR grant/deny poverty exemption. BOR must not deviate from adopted policy guidelines for "Substantial & compelling reasons", BOR must grant (full) 100%, 50%, and 25% for person who meets eligibility requirements of the Township will need STC approval for any other percentage reduction.
